## PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Noble Paws Incorporated, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "NPI"), I hereby agree to release, indemnify, and discharge NPL on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in dog sled tour activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: a dog irrespective of its training and usual past behavior and characteristics, may act or react unpredictably at times based upon instinct or fright; dogs may bite; Losing control of the dogs may result in collisions with other sleds and/or man made and natural objects such as bridges, trees, rocks, cliffs, streams and other obstacles; inclement weather, hypothermia, frostbite, avalanches; falling into a crevasse; and equipment failure. I understand that sled dog touring is a wilderness activity that exposes me to all elements of the outdoors and natural surroundings.

Furthermore, NPI employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

- I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely 2. voluntary, and I elect to participate in spite of the risks.
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless NPI from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of NPI's equipment or facilities, including any such claims which allege negligent acts or omissions of NPI.
- Should NPI or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to 4. indemnify and hold them harmless for all such fees and costs.
- 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
- In the event that I file a lawsuit against NPI, I agree to do so solely in the state of Alaska, and I further agree that the substantive law of 6. that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against NPI on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
